I certainly agree with the theme that the Convention Center is a critical opportunity to make a design statement that enhances Bloomington's built environment and sends a positive message to visitors.

One comment that I thought might be worth mentioning is related to a recent visitor's impression of Bloomington. We recently had a delegation from the Ames, IA Chamber of Commerce visit Bloomington. The group included an architect, and I asked him for his thoughts on architecture in Bloomington. He said he was very surprised by how little glass was used as a defining element on urban facades in downtown Bloomington. Since that time, I've looked around during my travels around downtown, and it's really true, there is very little glass in downtown Bloomington. Perhaps that is an opportunity to make a statement with the Convention Center.
